  - vii. Assist with the delivery scheduling of suppliers.
- 4. To include the environmental credentials of materials we purchase, within our procurement selection process.

Measured by;

- i. Selection process (PQQ) for all suppliers.
- ii. FSC/PEFC Chain of custody, wherever possible.
- iii. Recycled stationery products.
- iv. Local resourced materials.
- v. Eco friendly materials where available through our procurement process.
- 5. Only use timber sourced from sustainable resources.

Measured by;

- i. FSC/PEFC Chain of custody, wherever possible.
- ii. Monitored for compliance.

- 6. Reduce waste wherever possible through design, procurement, logistics, storage, protection & reuse, and ensure the BPEO is sought for the collection and treatment of waste from our sites to be recycled.

  Measured by;
  - i. Construction Environmental Plan (Site BEPO Measures);
  - ii. Design considerations and priorities given to reduction on environmental impacts/aspects and ecomanagement.
  - iii. The correct storage of materials on site to ensure protection and spillage procedures are in place.
  - iv. Segregation of materials on site.
  - v. Auditing of our waste contractors to ensure legal and best practice compliance.
  - vi. BREEAM (Building Research Establishment Environmental Assessment Methodology), where applicable.
  - vii. SWMP to be compiled (best practice) to established forecasted and actual waste reduction figures, to allow for future performance improvement, where applicable.
- 7. Engage with community and charitable programmes to seek opportunities for reuse of surplus materials including timber, paint, clothing etc.

Measured by;

- i. Project specific opportunities to be looked at.
- 8. Measure and reduce our carbon footprint Net zero carbon by 2040:

Measured by;

- i. Reduce our carbon footprint by:
  - a. Calculation of our business carbon footprint to establish our net zero carbon strategy reduce and offset.
  - b. Bulk delivery of materials (scope 3).
  - c. Assist with the delivery scheduling of suppliers (scope 3).
  - d. Encourage a car share policy and use of public transport (scope 1).
  - e. Bike racks to be made available on our projects (scope 1 when required).
  - f. Encourage the use of conference calls, by making the technology available to managers and staff (scope 1).
  - g. Monitor company mileage and set a benchmark target in relation to a reduction strategy (scope 1).
  - h. Green energy supplier (scope 2).
  - ii. Achieved Carbon Neutral in 2023.
- 9. Make all reasonable efforts to minimise or eliminate potential impact of construction activities on neighbours and the environment.

Measured by:

- i. Statutory noise monitoring (as applicable).
- ii. Considerate Constructors Scheme application (where applicable).
- iii. Good neighbour policy.
- iv. Neighbour liaison meeting and newsletter distribution on our projects (as applicable).
- 10. To regularly audit the suppliers of goods and services we use against the standards we set.

Measured by;

- i. All waste contractors to be audited for legal and best practice compliance.
- ii. All suppliers and contractors to be vetted (PQQ) prior to selection.
- iii. Ensure that our supply chain offer the BEPO.

## 11. Minimise energy usage through best practice.

Measured by:

- i. Monitor and set a benchmark on energy usage within our offices based on occupation.

- Regular meetings to discuss sustainability issues and to report improvements in design, particularly additional sustainability measure;
- Provide instruction to all trade contractors on project sustainability issues, and monitor their compliance to our policy and our clients;
- Review and assessment of trade contractor sustainability performance;
- Assistance in setting a clear agenda for project sustainability;
- The on-going training in current sustainability practices for the Project Team;
- To advise the Project Management Team/Client on the on-going consideration of economic and social sustainability issues;
- Workshops and meetings to be held to clarify any issues regarding waste management and allow feedback and decisions on sustainability improvements.
- We will continue to develop our sustainable approach within the business.
